

RULES OF THE GIVEAWAY

GIVEAWAY "NEURAE x UNILE"

NO PURCHASE IS NECESSARY TO ENTER OR WIN

1. ORGANIZER

The company c.f.e.b. SISLEY, a simplified joint stock company, with a capital of 1,000,000 euros, whose head office is located in France, 3 avenue de Friedland 75008 Paris and registered in the Paris Trade and Companies Register under number 722 003 464 and the company UNILE SELFCARE, whose head office is located 586 rue de la mairie 01120, Thil, (hereafter the "Organizing Companies"), organize from march 29 2026 at 10:00 a.m (French time) to april 5 2026 at 12:00 noon (French time) a giveaway around "Neurae" and « Unile Selfcare » products on the Instagram accounts Neurae and Unile (hereinafter the "Giveaway") according to the rules set out in these terms and conditions.

2. PARTICIPATION

The Giveaway, with no purchase obligation, is opened internationally to any person who has attained majority and has legal capacity in his/her country, excluding employees of the Organizing Companies or its subsidiaries, and their families. In the event of a dispute, proof of identity may be requested.

To participate, all you need to do is to, via an internet connection (computer / mobile):

- Follow the Instagram account Neurae (@Neurae) ;
- Follow the Instagram account Unile (@Unile.selfcare) ;
- Like the Instagram post in which the Giveaway is announced and tag one (2) friends in one comment;
- Accept the conditions & rules of the Giveaway.

Any incomplete, inaccurate, fanciful data or one that does not meet all of these conditions will not be taken into account and will therefore invalidate the entry.

Only one entry per person is accepted for the duration of the Giveaway : from march 29 2026 at 10:00 a.m (French time) to april 5 2026 at 12:00 a.m (French time).

All other entry methods are excluded.

The Giveaway does not involve any prior expenditure on the part of the participant of any kind. Consequently, no reimbursement of any kind can be made at the expense of the Organizing Companies.

3 PRIZE

3.1. Prize

Only one (1) prize per participant.

4. COMMITMENT, GUARANTEES AND DISCHARGE OF THE PARTICIPANT

5. REGULATION
